## **AGENDA**

- U.S. and Canada enjoy the largest energy trade relationship in the world and Canada is viewed as the most important trading partner to the United States. This partnership supports an estimated 174,000 Michigan jobs.
- Canada is the single largest foreign supplier of energy to the United States providing 17% of U.S. oil imports and 18% of the U.S. natural gas demand.
- Aside from oil and gas, Canada's main exports to the United States are metals and lumber.
- There are more than 200 million crossings of the U.S. Canada border every year. The Detroit-Windsor and Port Huron-Sarnia crossings represent almost half of all traffic between the United States and Canada.
- Canada is the seventh-largest foreign investor in the United States with investments in manufacturing, wholesale trade, real estate, petroleum, and services such as finance and insurance.
- U.S. investment in Canada is primarily in mining and smelting industries, petroleum, chemicals, the manufacture of machinery and transportation equipment, and finance services.

Paul M. Tellier Corporate Director

Paul M. Tellier is a Director of Alcan, Inc., Bell Canada Enterprises (BCE), Bell Canada and Telsat Canada; Canadian Forest Products (CANFOR), GM Canada, and; McCain Foods Ltd. He is also Strategic Advisor to Société Générale, a global bank head-quartered in France. Mr. Tellier is a member of the Board of the Canadian Institute for Advanced Research (CIAR).

Mr. Tellier was President, Chief Executive Officer and Director of Bombarier Inc.. in 2003 and 2004. Prior to this, he was President and Chief Executive Officer and a Director of the Canadian National Railway Company (CN), a position he held for 10 years.

From August 1985 until he took up his post at CN in 1992, Mr. Tellier was Clerk of the Privy Council and Secretary to the Cabinet of the Government of Canada, the top public servant in the country. He served in many positions in the public sector, including Deputy Minister of Indian Affairs and Northern Development in 1979 an as Deputy Minister of Energy, Mines and Resources in 1982.

Mr. Tellier is a graduate of the universities of Ottawa and Oxford, England and was admitted to the Quebec Bar in 1963. He has received several Honorary degrees in the areas of law, science, and commerce.

Mr. Tellier was appointed Companion of the Order of Canada in 1993. He has received numerous awards including Canada's Most Respected CEO, KPMG/lpsos-Reid Survey, 2003; McCullough Logistics Executive of the Year Award, National Transportation League, 2001; Canada's Outstanding CEO of the Year, 1998, and; Governor General's Outstanding Achievement Award, 1990.
